### North Cumbria Place PLT Provision for 2025

The ICB continues to be committed to its General Practice workforce and understands the importance of PLT to ensure the workforce has protected time to receive education, training, and development. We are pleased to confirm each practice will have access to a total of six PLT sessions during 2025: -

- Two of the sessions will be ICB facilitated sessions. These sessions will include face to face conferences for clinicians to give the opportunity to network with colleagues. We will continue in the same format as 2024 with two GP conferences and two nursing conferences. We will also include one conference event specific for HCAs and one non-clinical face-face networking event, the remaining ICB facilitated event for non-clinical staff will be online.
- Two sessions will be for PCN developments and should include all staff groups.
- Two of these sessions will be practice based development sessions.

Clinical cover will be provided for all six sessions, with cover commencing from 13:00 and ending at 18:30. Tea and coffee will be provided during the face-to-face sessions. Lunch will not be provided.

### **Suggestions for Practice Based afternoons:**

- Clinical/improvement of patient care to include peer review,
- Service or Quality improvement
- Safeguarding
- Mandatory practical training (We request this is done in conjunction with other educational activities throughout the afternoon)
- Clinical supervision/mentoring
- Practice development.

- Business and financial meetings
- Training which could be deemed as part of day to day running of practice
- Industry sponsored events
